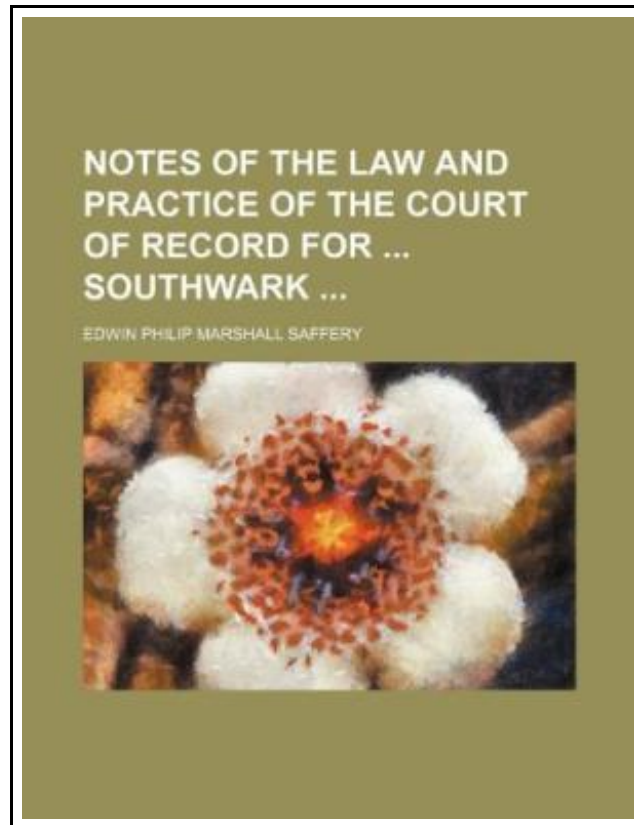

Not illustrated. 1868 Excerpt: .the disposal he may have made of such property since contracting the debt, and may make an order thereon, in certain cases, (for which see the act) for his committal to prison, for any term not exceeding forty days, to the common gaol, wherein the debtors under judgment and execution of the superior courts of justice may be confined, within the county, city, borough, or place in which such debtor shall be resident, or to any other gaol or debtors prison within the same county, city, borough, or place, which shall by declaration of one of Her Majesty s principal Secretaries of State, be allowed as a place of imprisonment under this Act, so long as such declarations shall remain in force and unrevoked. And by sec. 2 no protection or interim, or other order issuing out of any court of bankruptcy, or for the relief of insolvent debtors, or any certificate obtained after such order for imprisonment, under this Act shall be available to any debtor imprisoned under such order as aforesaid. And by The Bankruptcy Act, 1861, (See sections 100 and 104) any person so committed cannot obtain his release by being included in the returns of the goaler made in pursuance of that act. For the fees payable under 8 9 Vic., c. 127, see page 116. The Act does not direct how the summons is to be served, but no doubt it should be personal, and that leaving it at the house...
